Liquid Trade Waste Fees and Charges

The general charges for Trade Waste have been determined in accordance with Ipswich Water's Trade Waste Policy. This policy is based on the DPI model Trade Waste Policy and the National Strategy on Trade Waste Management.

The conditions of licence for Trade Waste Generators will be per Council's approved Trade Waste Policy. The categories to which licences or legal agreements are assigned will be outlined in Council's Trade Waste Policy.

Any discharge of Liquid Trade Waste that complies with Council's Trade Waste Policy but which exceeds Category 1 base levels for volume or strength, will be charged per excess fee structure as adopted in Council's Budget Resolution.
